DEPOSIT:

A deposit of \$1000 is due no less than 30 days prior to the wedding date, with the remaining balance to be paid at on the date of the wedding.

RESERVATION:

A signed contract and deposit fee are required to reserve the coverage.

EXPENSES:

The CLIENT is responsible for all travel, accommodation, meal and transport costs that fall outside those allocated in the packages. Mileage is billed at .37 cents per mile. Air transportation, if required, is paid by the CLIENT.

EVENT GUIDE:

Thad Allender Photography recommends that CLIENT designate an "event guide" to point out important individuals for informal or candid photographs to the PHOTOGRAPHER during the wedding that they wish to have photographed. The PHOTOGRAPHER will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for photograph's.

HOUSE RULES:

The PHOTOGRAPHER is limited by the guidelines of the ceremony official or reception site management. CLIENT agrees to accept the technical results of their imposition on the PHOTOGRAPHER. Negotiation with the officials for moderation of guidelines is the CLIENT's responsibility; the PHOTOGRAPHER will offer technical recommendations only.

COPYRIGHTS:

Until final payment for services rendered is made, the photographs produced by the PHOTOGRAPHER are protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without the PHOTOGRAPHER's explicitly written permission. Upon final payment by the CLIENT, limited copyright ownership of the resulting images will be transferred to the CLIENT under the following conditions: The images are the property of CLIENT for personal use and for the purposes of the reproduction and giving of photographs to friends and relatives. The CLIENT must contact the PHOTOGRAPHER for editorial and commercial usages that fall outside the agreement outlined in this contract.

MODEL RELEASE:

The CLIENT hereby grants to the PHOTOGRAPHER and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases the PHOTOGRAPHER and its legal representatives and assigns from all claims and liability relating to said photographs.

LIMIT OF LIABILITY:

In the unlikely event that the PHOTOGRAPHER is injured or becomes too ill to photograph the event, the PHOTOGRAPHER will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. The PHOTOGRAPHER takes the utmost care with respect to exposure, transporta-

tion, and archiving the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond the PHOTOGRAPHER's control, the PHOTOGRAPHER's liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

SECURITY DEPOSITS:

In the event of cancellation, the security deposit paid is non-refundable. It shall be liquidated damages to the PHOTOGRAPHER in the event of a breach of contract by CLIENT. The CLIENT shall also be responsible for payment for any materials charges incurred up to time of cancellation.

COMPLETION SCHEDULE:

Image processing takes approximately two weeks.

PAYMENT SCHEDULE:

Balance payable in full at time of wedding. A bill will be supplied at the wedding.

ENTIRE AGREEMENT:

This agreement contains the entire understanding between the PHOTOGRAPHER and the CLIENT. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties want to waive one provision of this agreement, that does not mean that any other provision is also waived. The party against whom a waiver is sought to be effective must have signed a waiver in writing. I have read and understood the terms above. I hereby agree to the terms of this agreement.
